The first annual Trial Lawyers Summit in South Beach in January was successful in accomplishing each aspect of our mission. As an excellent exemplar of the type of project that the Forum and Round Table may undertake, Susan Saladoff, a member of the Trial Lawyers Round Table, addressed the groups about her award-winning documentary Hot Coffee. Susan discussed how we can assist her in gaining the widest possible distribution of her film, which exposes the campaign of lies about the infamous McDonald's coffee case and other factual distortions which are the bedrock of tort reform. A highlight of the Trial Lawyers Summit was the Awards Luncheon at which The National Trial Lawyers Lifetime Achievement Award was presented to Peter Neufeld and Barry Scheck of the Innocence Project for their incredible work in exonerating and freeing, to date, 287 citizens who were wrongfully convicted of crimes and imprisoned, many on death row. This important work, which Peter and Barry perform pro bono, is a high profile reflection of the incalculable hours of pro bono work contributed by criminal defense lawyers in our organization to protect the rights of individuals and preserve and protect the rights and freedom of all of our citizens.

In the political cauldron that America has become in the past two decades, the disdain, disrespect and diminution of individual rights proceeds apace and the efforts of each of us to protect those rights must grow exponentially to meet the ever increasing challenges to the constitutional rights of citizens. Part of the mission of The National Trial Lawyers is to promote excellence through advocacy training. It is difficult for our current generation of young trial lawyers to believe that trial lawyers in my generation had twelve to fifteen cases set for trial every Monday morning in the 60s and 70s and that we trained for trials by going to trial. However, one of the byproducts of lawyer advertising and tort reform is that, in many jurisdictions, the opportunities for young trial lawyers to hone their trial skills in the courtroom are greatly diminished.

In order to offer guidance and recognition to our young trial lawyers, we formed a new professional organization comprised of America's top young trial attorneys known as the Top 40 Under 40. Membership into The National Trial Lawyers: Top 40 Under 40 is by invitation only and is extended exclusively to those individuals who exemplify superior qualifications, trial results, and leadership as a young lawyer under the age of 40. Selection is based on a thorough multi-phase process which includes peer nominations combined with third-party research. The result is a credible, comprehensive and impressive list of young attorneys chosen to represent their state.

Through the help of our members and affiliate organizations, we will choose the top 40 trial lawyers under the age of 40 in each state and work with them to present Advocacy Skills training from America's premier trial lawyers. We began at the Summit with skill lectures from such outstanding lawyers as Peter Perlman, Tommy Malone and John Romano. The Top 40 Under 40 members will have considerable input into the type of advocacy training they wish to receive.
